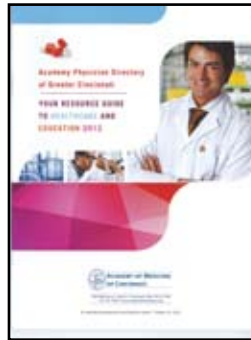

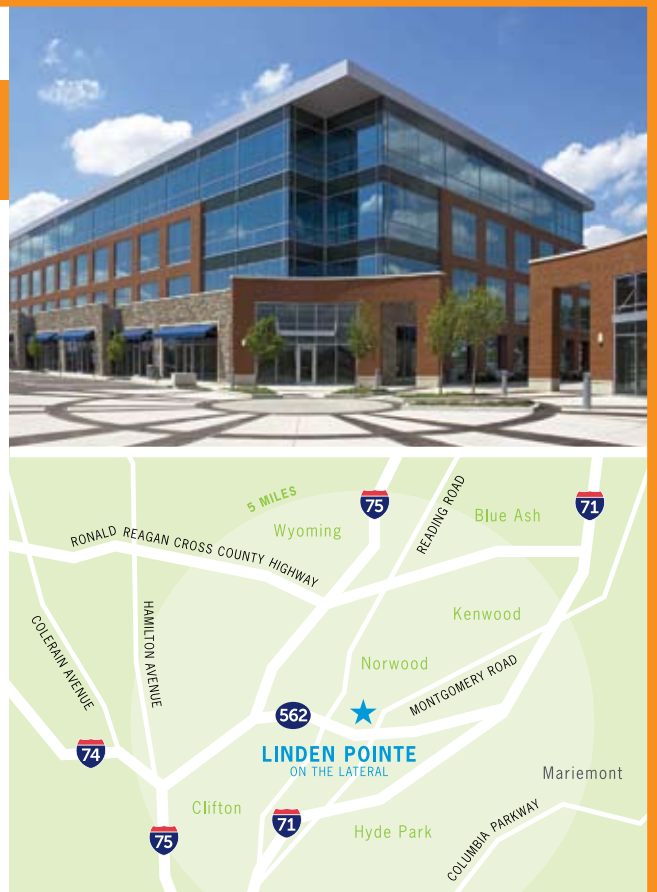

Project Access Update

Since the first Project Access patient was seen on March 6, a total of 63 patients have been seen by physician volunteers in the specialties of cardiology, cardiovascular surgery, dermatology, ENT, gastroenterology, general surgery, gynecology, hand surgery, neurology, ophthalmology, orthopedic surgery, pathology, urology, as well as primary care. To be eligible for Project Access, patients must be uninsured and not eligible for any form of publicly-funded insurance; under 200% of the federal poverty level (family of four-\$44,700); and residents of Hamilton County.

The First District Delegation held a meeting on September 12 to begin preparations for the 2013 Annual Meeting of the OSMA House of Delegates, scheduled for April 5-7, 2013, at the Hilton Columbus at Easton.

Ideas for seven resolutions were presented for discussion:

- clear & convincing evidence,
- concussion care,
- patient steerage,
- recovering overpayments on old medical claims,
- fair reimbursement for the care of patients on Medicaid and Medicare HMOs for non-FQHC providers,
- graduate medical education funding, and
- medical student loans.

All will be worked up in resolution format and brought back to the next meeting, scheduled for Monday, November 19, for further discussion. Resolutions must be submitted to OSMA by early February to be considered at the annual meeting.

Hamilton County is in need of additional alternate delegates. Physicians who agree to serve as delegates or alternate delegates are expected to attend the three-day annual meeting of the OSMA House of Delegates to represent their counties, participate in discussion on resolutions that address health care policy, serve on reference committees, vote on resolutions, and elect delegates/alternate delegates to represent Ohio at the American Medical Association. From this meeting, the legislative agenda for OSMA evolves. Delegates/alternates have the opportunity to not only help decide health policy but to submit resolutions of behalf of their own district.

Medical Board shelves implementation of MOL

At its meeting on October 11, the State Medical Board of Ohio voted to suspend further consideration of participation in the Maintenance of Licensure (MOL) pilot project with the Federation of State Medical Boards (FSMB). The Medical Board will not be pursuing the implementation of additional MOL activities.

This decision was made after extensive discussion by the members of the Medical Board over the past two years and with continual input from organized medicine regarding the feasibility of implementing MOL into Ohio's biennial physician licensure renewal process.

The current requirement for physicians to complete 100 hours of CME every two years remains in effect and the board encourages licensees to select CME programs related to the physician's area of practice.

Medical Board names interim executive director

On October 12, the State Medical Board of Ohio named Kimberly C. Anderson, Esq., Interim Executive Director, following the resignation of Richard A. Whitehouse. Ms. Anderson also serves as the Assistant Executive Director of Investigations, Compliance & Enforcement for the agency.

UC appoints Ono as 28th President

The University of Cincinnati has appointed Santa Jeremy Ono as its 28th President.

In announcing the appointment, C. Francis Barrett, Chair, Board of Trustees stated, "I and my fellow trustees unanimously voted to appoint Dr. Ono to serve as this university's chief executive. In making this decision, the Board was inspired by the unanimous recommendation of a broadly representative search committee. Dr. Ono impressed the search committee and the Board of Trustees with his apparently unlimited energy and enthusiasm. He has, in his brief term as interim president, made the extra effort to be accessible to all of the university's constituencies – especially our students – and has demonstrated that he values consensus. His efforts are based on a university in which students occupy the center of all of our activities, and where learning is paramount. He understands, as a faculty member, the importance of our academic mission. The staff understands that he values decisions based on process fueled by data."



After accepting the position, Dr. Ono said, "What a tremendous honor it is to be selected as the University of Cincinnati's 28th President. Every day, I meet students, alumni, faculty, staff, patients, and donors who reinforce for me that the University of Cincinnati is among the finest institutions in our nation. The outstanding talent, energy and spirit that I see here as well as the pioneering educational and research initiatives we pursue are what make our university so unique, so extraordinary and so innovative. I want to thank the entire UC community for their outpouring of good wishes. UC's reputation is rising, and I am very excited to be a part of that momentum."

Ono also serves as professor of pediatrics within UC's College of Medicine and professor of biology in UC's McMicken College of Arts and Sciences. Ono's principal research interests focus on transcriptional regulation in the human immune system, mechanisms of mast cell dependent inflammation on the ocular surface and the immune component of age-related macular degeneration.

News for physicians from the Ohio Department of Health on fungal meningitis outbreak

The FDA advises health care professionals to follow-up with patients who were administered any injectable medication from or produced by the New England Compounding Center (NECC), including injectable ophthalmic drugs used in conjunction with eye surgery, or a cardioplegic solution purchased from or produced by NECC after May 21, 2012. Health care professionals and medical care organizations should inform patients who received the NECC products noted above of the symptoms of possible infection and instruct patients to contact their health care provider immediately if they experience any of these symptoms.
