Pain management legislation passes — effective immediately

Legislation aimed at curbing prescription drug abuse and diversion in Ohio (HB 93) received unanimous support from the House and Senate and was signed by Governor Kasich on May 20. The bill is being enacted with an emergency clause, meaning the law will become effective immediately unless otherwise noted in the summary of HB 93.

The legislation is widely regarded as one of the most aggressive efforts in the country to address the prescription drug abuse epidemic ravaging parts of Ohio. It is intended to provide the Medical and Pharmacy Boards and law en-

Nearly four out of five physicians still need to complete an EFT Form with CIGNA

According to CIGNA Government Services (CGS), as of mid-May, only 21 percent of Ohio providers have completed an approved new electronic funds transfer (EFT) form and sent it to the new Medicare Part B Carrier, CGS. That means nearly four out of every five providers in Ohio are risking a discontinuation of Medicare payments after June 18, 2011. It is important that you complete this process now.

With the transition to a new Medicare Part B Carrier in Ohio on June 18, 2011, your practice must take action in order for you to continue to receive payments for your Medicare services. You must complete a new electronic funds transfer (EFT) form and send it to the new Medicare Part B Carrier, CIGNA Government Services (CGS).

You should have received a letter from CGS explaining the process with the proper EFT information. Follow the directions in the letter and complete all of the necessary forms and information. Please always use caution when complying with such requests so that you don't mistakenly respond to a fraudulent request. However, it is

necessary to complete a new EFT form so that you continue to receive your Medicare payments after the transition from Palmetto GBA to CGS as Ohio's Medicare Part B Carrier.

Blue Cross of South Carolina (BCSC) purchased CGS in April. BCSC also owns Palmetto GBA and TrailBlazer Health Enterprises, both are Medicare carriers in other regions.

The purchase of CGS is not expected to affect the transition in June. However, this acquisition does not change the fact that your practice must complete a new EFT with CGS. forcement additional tools to shut down pill mills and prosecute rogue prescribers that are unethically and illegally prescribing and dispensing medications. It is not intended to impede access to legitimate medical care for chronic pain patients.

HB 93 will primarily impact physicians in three ways: it will require licensure of pain management clinics, authorize regulatory boards to establish standards for Ohio Automated Rx Reporting System (OARRS) review, and severely restrict in-office dispensing of controlled substances to patients.

The Medical Board approved an updated version of rules governing pain management clinics so please review the latest information. If you treat pain or chronic pain, it is crucial that you and your practice understand the scope of these changes and the impact of the law on your practice.

E-prescribing impacts 2012 Medicare reimbursement

To avoid a reduction in Medicare reimbursement, physicians must begin to utilize e-prescribing before June 30, 2011.

Under Section 132 of the Medicare Improvements for Patients and Providers Act of 2008 (MIPPA) if eligible parties do not meet the e-prescribing criteria, CMS is authorized to reduce payments in 2012, with regard to all of the eligible professionals' Part B-covered professional services, by one percent of the Physician Fee Schedule (PFS) amount that would otherwise apply to such services.

For purposes of determining which eligible professionals or group practices are subject to the payment adjustment in 2012, CMS will analyze claims data from January 1, 2011 – June 30, 2011 to determine if the eligible professional has submitted at least 10 electronic prescriptions during the first six months of calendar year 2011.

That means at least 10 electronic prescriptions must be submitted by June 30, 2011, or face a one percent reduction in your 2012 Medicare reimbursement.

If your practice does not have a full EHR system capable of generating e-prescriptions, you may still meet the Medicare e-prescribing requirements by utilizing a stand-alone e-prescribing module.
